With this application, I accept that I am personally responsible to meet all the requirements towards maintaining this status. I confirm that I am committed to the Code of Conduct, the Constitution, Rules, and Policies of SA Hunters. Furthermore, I promise to comply with the Code of Conduct for Professional Hunters that are members of SA Hunters.

**Code of Conduct for Professional Hunter:**

As a Professional Hunter and a member of SA Hunters, I promise to observe the following:

- Heed all written and unwritten hunting laws and regulations;
- Never take anything from nature that I am not entitled to;
- Acknowledge and respect the rights and interest of landowners and local communities;
- Hunt with compassion and only use from nature that which is sustainable;
- Actively conserve fauna en flora, soil and water that represents life, and treat it with respect and care;
- Use a firearm competently and with discretion and respect for life;
- Hunt with humility, respect my fellow hunters, and promote the hunting heritage;
- Always behave with honesty and sincerity and do not allow profit-seeking to detract from these principles;
- Never mislead a client or attempt to deceive him/her;
- Always try to deliver on the services agreed upon with clients and to ensure their safety; and
- Never behave in a manner that will bring the good name of SA Hunters and its member into disrepute.

I am committed to abide by this Code of Conduct and to respect and promote all the Association's policies (e.g. the Association's position on the intensive breeding of indigenous species and the hunting of game that are products of these intensive breeding practices, but not restricted to) and not to get involved in activities that go against any of these policies. I accept that should I disregard any of the above, my status as Professional Hunter within SA Hunters could be suspended, or my membership of SA Hunters could be cancelled summarily.

Furthermore, I confirm that I fully endorse and accept the Constitution, Internal Rules, and Disciplinary Procedure of SA Hunters.

I confirm that no disciplinary or criminal cases regarding the above, have been taken against me, whether such a case has been concluded or is still pending. (If so, a full statement in this regard must accompany this application with the understanding that approval of Professional Hunter Status will be at the discretion of the Board of SA Hunters.)

I accept that the minimum requirement for obtaining and maintaining the Professional Hunter Status with SA Hunters, depends on acquiring a valid licence as Professional Hunter in at least one province or country in Africa; that I am a paid-up member of SA Hunters; and that I committed to this Code of Conduct.

I accept that failure to provide the above information with my application, or any behaviour afterwards that breaches my commitment to the above, will be sufficient reasons for immediate suspension of my Professional Hunter Status with SA Hunters, and potential disciplinary charges against me.

I accept that my membership of SA Hunters will be terminated immediately if I violate any provincial or national hunting and/or conservation legislation and/or regulations.

I also accept that if my membership of SA Hunters expires, that my status of Professional Hunter will also lapse; and that I will have to reapply for Professional Hunter Status once I resume paying my membership fees to the Association.
