Dear Colleague

This is the seventh of our special newsletters on the Draft Firearms Amendment Bill that specifically deals with requirements relating to dedicated hunting, sport shooting and professional hunters. Thank you for your continued participation and engagement on this matter – please remember that all our petitions will remain open until 2 July 2021 for signatures. You may continue to send your comments to the Secretariat for the Police Service using the prepared and pre-populated sheets or your own comments. During the first week of publishing the amendments, 17 000 comments and petitions were submitted by various organisations and individuals. We need to keep up the momentum!

Together with today's newsletter, you will find the following:

1. SA Hunters' third petition that you can print out and sign, as well as the link to submit it electronically on the change.org platform. We received some queries around this platform that provides options to donate or share different petitions. These are merely the terms of use of this platform. Simply select "skip" or the "no thank you" option to continue. You will have to confirm your email address to participate.
2. The third of a series of comments that enable you to submit comments directly to the Civilian Secretariat for the Police Service. We also attach a WORD document option for use. Should you use the WORD option, please save it on your desktop/system as "Comment: Draft Firearms Amendment Bill", complete the fields (our comments are already pre-populated, with a section to insert your own opinion/comments. When completed, send by email to: comments.fcabill@csp.gov.za. Please note that these documents are only available in English because there has been an explicit instruction that this communication should be in the country's business language.
3. The eighth information sheet, specifically linked to dedicated hunters, sport shooters and professional hunters.

SPESIALE NUUSBRIEF: 23 JUNIE 2021

Hierdie is die sewende spesiale nuusbrieff oor die Konsepvuurwapenwysigingswetsontwerp wat spesifiek handel oor die vereistes vir toegewyde jagters, toegewyde sportskuts en beroepsjagters. Dankie vir die voortgesette deelname en kommentaar oor hierdie aangeleentheid. Onthou dat alle petisies tot 2 Julie 2021 beskikbaar is om te teken. Lede kan steeds hulle eie kommentaar voeg by die voorbereide kommentaar op die wetsontwerp en dit direk aan die Siviele Sekretariaat vir die Polisie diens stuur. In die eerste week na die wysigings gepubliseer is, het meer as 17 000 organisasies en individue reeds kommentaar ingedien. Ons moet hierdie druk volhou!

Die onderstaande inligting is by van dag se nuusbrieff ingesluit:

1. SA Jagters se derde petisie wat lede kan uitdruk en teken, of gebruik die skakel na die elektroniese weergawe op change.org platform. Ons het navrae ontvang oor opsies op hierdie platform wat mense geleentheid gee om geld te skenk of inligting te deel. Hierdie is bloot voorwaardes vir die gebruik van die platform en daar is geen verpligting om iets te gee nie. Kies net "skip" of "no thank you" en gaan voort. Dit is wel nodig om jou e-posadres te bevestig om te kan deelneem.
2. Die derde dokument as deel van 'n reeks kommentaar wat jou in staat stel om kommentaar direk aan die Siviele Sekretariaat vir Polisie te stuur. Die WORD-weergawe van die dokument is ook aangeheg. Liasseer dit op jou eie rekenaar as "Comment: Draft Firearms Amendment Bill", voltooi die velde (ons kommentaar is reeds ingevul met 'n afdeling om jou eie kommentaar by te voeg. Wanneer dit voltooi is, stuur dit aan comments.fcabill@csp.gov.za. Let daarop dat hierdie dokumente slegs in Engels beskikbaar is omdat daar 'n spesifieke instruksie was dat alle kommunikasie hieroor in Suid-Afrika se besigheidstaal ingedien moet word.
