Firearm Licence Application

Complete the SAPS 271 application form in black ink

Attach the following documents to your application:

- Two copies of the identity document
- Copy of the competency certificate
- Copy of proof of training; POSLEC, SASSETA, or PFTC Statement of Results
(The training certificates are not a requirement for the application, but some firearms officers request them. Just take it with you.)
- Proof of address (not older than 3 months)
- Three full-colour photos of the safe with the door closed, with the door open, and one showing the bolts with which it is secured.
- Complete motivation for each firearm licence that you are applying for
- Endorsement confirming that the firearm is suitable for the purpose for which it is motivated
- Any additional documentation supporting the motivation, e.g., hunting photographs, Invitations from farmers confirming that you are allowed to hunt on their farm, Copies of certificates or any other proof of participation in sports shooting activities
- Article 16 applications require proof of membership and dedicated status (See supporting documents for SAJWV members)
- Two full-colour passport photos
- R168 cash per application

Supporting Documents for SAJWV Members

The following SA Hunters documents are available on members' profiles on the online membership administration system:

- Copy of your latest SAJWV membership certificate
- Endorsement for firearm suitability (request from the national office)
- For members with dedicated status:
 - Proof of dedicated hunter status with a letter of good standing
 - Proof of dedicated sports shooter status with a letter of good standing
 - A copy of the member's hunting and sports shooting activity report

If you are buying the firearm from a firearm dealer, the dealer must:

Attach the SAPS 350(a) form to the SAPS 271 application form with the following sections completed and signed:

- Section E 1 to 1.11

- Section F, 41 TYPE C (Companies) 42 to 58
- Section F 81 (DECLARATION BY PERSON WHO IS LAWFULLY IN POSSESSION OF THE FIREARM) 82 to 87.

If you are taking over the firearm in a private transaction, the current owner must:

- Attach a copy of their ID document to the application form
- Attach a copy of the existing firearm licence to the application form
- Choose Section F, 1.2 A (private owner)
- Complete Sections A (private owner) 4 to 15 on page 3
- Complete Sections F 81 to 87 on page 5 and sign.

If you are inheriting or buying the firearm from an estate, attach the following documents to the application:

- A copy of the deceased's firearm licence
- A copy of the deceased's ID document
- A copy of the deceased's death certificate
- A copy of the executor's appointment letter managing the estate
- A letter from the executor approving the transfer of firearms and authorising the applicant to apply for a firearm licence for the respective firearm
- A copy of the executor's ID document
- Choose Section F, 1.2 E (estate)
- Executor completes section 63 Type E (estate) on page 4.
- Executor completes and signs F; 79 to 87 on page 5.
