Storage Permit

Complete the [SAPS 539](#) in black ink

Note: With a storage permit, the firearm may only be stored, not transported, or used.

Attach the following documents to your application:

- Copy of the owner's ID
- Copy of the relevant firearm owner's licence to be stored
- Copy of the ID of the person in whose possession the firearm will be stored
- Copy of the competency certificate of the person in whose possession the firearm will be stored
- Proof of address of the person in whose possession the firearm will be stored
- Copy of firearm licences of the person in whose possession the firearm will be stored

Take the storage permit to your DFO for approval.

The owner must receive a copy of the storage permit.

In cases where someone stores a weapon that is part of an estate, complete the storage permit and attach the following:

- Copy of the deceased's ID
- Copy of the deceased's death certificate
- Copy of the deceased's licence for the rifle (or rifles) you will be storing
- Copy of the executor's appointment letter
- Letter from the executor approving that you may store the firearms and that the applicant is authorized to apply for a firearm licence for the relevant firearm
- Copy of the owner's licence for the firearm to be stored
- Copy of the ID of the person in whose possession the firearm will be stored
- Copy of the competency certificate of the person in whose possession the firearm will be stored
- Proof of address of the person in whose possession the firearm will be stored.
